## Adoption Agreement

We the Snowflake-Taylor Police Department, 602 S. Main St. Snowflake, Arizona 85937 in accordance with the policies of the Snowflake-Taylor Police Department and the Town codes of Snowflake and Taylor, reserve the right to reject any adoption application which does not satisfy our standards for responsible pet ownership.

I the undersigned adopter, understand that this document is a legal contract and I hereby agree to provide:

1. In accordance with the mandatory spay/neuter law of the State of Arizona, sterilization by a participating veterinarian of my choice on or before\_\_\_\_\_. Dogs or Cats must be sterilized within 30 days after adoption or after sexual maturity (usually 16 weeks of age).
  - a. Note to veterinarian: if the pet has been previously sterilized, please verify below:

  - c. Upon receipt of verification, the Snowflake-Taylor Police Department will refund the sterilization deposit to the adopter.
2. Veterinary care necessary, immunizations, license(s) and ID tags. Your veterinarian will establish a treatment schedule. Be advised that young animals may require a series of immunizations.
3. Protection from small untrained children who unknowingly, can inflict injury or cause the death of a pet.
4. Supervision by a responsible adult to ensure the pet is properly fed, groomed, kept free of parasites; fresh water and protection from the elements is available at all times and that the pet receives exercise, love and attention.

I the undersigned adopter, further understand and agree to the following:

- A. This pet will not be used for vivisection, ritualistic procedures, medical or any other type of experimentation, nor will it be subjected to cruelty or suffering of any kind.
- B. The Snowflake-Taylor Police Department has the right to inspect the premises where this pet is to be kept, and if subsequent investigation reveals that an appropriate home is not being provided in accordance with Snowflake-Taylor Police Departments standard, the pet will be retrieved and returned to the Snowflake-Taylor Police Department Animal Shelter. In this instance neither the adoption fee nor the sterilization deposit will be returned.
- C. If this pet is not spayed or neutered as stated above all sterilization deposit(s) will be forfeited. The adoption fee is **not** refundable.
- D. The Snowflake-Taylor Police Department is not responsible, and cannot be held liable for any personal injury or property damage caused by the pet adopted from the Department.
